



Contract for A.H.A.V.A. English Program 2017-18 תשע"ח – 3rd-6th Maaleh Adumim

1. Classes begin the week of September 3rd, 2017. Length of the class is 60 minutes.
2. Classes take place once a week. There will be a total of 29 classes from September 2017 through June 2018. **When the regular schools are closed, there are no A.H.A.V.A. classes.**
3. Full annual tuition is 1,600 NIS. There are several opportunities for tuition discounts. See below.
4. Tuition is to be paid in 10 post-dated checks for the first of each month (Sep. 1st, 2017 to June 1st, 2018) The first payment includes the registration fee.
5. PayPal/Cash payments by: September 15th 2017, December 1st 2017, and March 1st 2018. To pay by bank transfer, our details are: א.ה.ב.ה. אנגלית הנלמדת בשיטה הטבעית, חשבון, סניף 001, בנק הדואר 09, 02749595
6. Registration: There is a non-refundable registration fee of 50 NIS for the 1st child; 20 NIS for each additional child enrolled. Registration assures your child's place in the program.
7. Workbooks are 100 NIS per book, payable later in the year, if used.
8. **Important:** Cancellation is only by notification to the A.H.A.V.A. office (02-535-6532). Lack of attendance is not proof of cancellation.
 - a. The first lesson is a trial lesson - there is no charge for cancellation after the first lesson.
 - b. After three months of school (December 1st, 2017) there is a cancellation fee of 100 NIS.
 - c. After February 1st 2018 there will be **no** refunds.
9. If the group misses a class because of the teacher's absence, A.H.A.V.A. is required to provide a make up lesson. If that is not possible, the corresponding tuition will be refunded.
10. There is no refund for classes that the child misses, no matter what the reason.
11. Students will display work and projects produced during the school year (at the Academic Fair in June).
12. A.H.A.V.A. reserves the right to expel a child from the program for the following reasons:
 - Discipline problems
 - Inability to maintain the academic level of the group
 - Non-payment of tuition.

The following tuition discounts are available:

1. **20 NIS** discount (per family) for registration *before* September 1st, 2017.
2. **100 NIS** discount when *all* forms and payments or postdated checks are in *before* September 15th, 2017.
3. An additional **200 NIS** discount* per child is available for families earning less than 2,500 NIS a month per family member (net income). Please sign the declaration below if you are eligible for this discount.
4. Families with more than one child enrolled in the program *and* not eligible for the aforementioned discount based on income, are eligible for a **200 NIS** reduction for each additional child in this program, and a **250 NIS** reduction for each additional child in the K-2 program.
